# <u>Principal's report: - Presented by Gary Johnson</u>

#### **Curriculum and Administration**

- The school has enjoyed a very settled start to the year with students quickly settling into work. Year 7 students are particularly settled and seem to have made the transition from primary to secondary very comfortably.
- NETWORK has provided on update on most of the happenings around the school over the vacation. Disappointingly much of the work which occurred over the holidays was not of a standard we are happy with and the power upgrade was delayed. Repairs continue and hopefully we will enjoy a better run as the year progresses.
- As mentioned in NETWORK the aircon is close to being finished. We are just waiting for the power upgrade and some units from OS to arrive. However, we have been able to switch on large sections of the school this week.
- Student numbers for 2022 are all but finalised with the total enrolment being 2088 students, slightly greater than at the same time last year. Our largest year group is year 11 with 364 students.

- At the present moment the school has a number of unfilled positions being filled by very competent casual staff. We are in the process of filling these in a permanent capacity and hopefully all new staff will be on the team by the start of next term. A full list of new staff was published in the first Network of term.
- The senior executive has held a number of planning sessions to review and clarify the school goals for 2023. The work the P&C completed last year on the SWOT analysis proved to be valuable in aiding our task. Focus for the year will continue to be on improving student learning, student wellbeing – particularly the introduction of the RIOT training and community engagement.
- Today's Valentine Day roses proved to be a great success with students
- 2022 HSC Results, Presentation of PP with details showing student and school growth over the past 20 years.
- I hope all families received a copy of Network via email this week. If you haven't please check with the school that your email address is up to date.
- BYOD Program My thanks to the community for the support of this initiative. The vast bulk of students are now connected and staff have begun using these in class.
- School photographs all but completed. All seemed to go very well.
- Thanks to Ron and P&C for sponsoring second prize at High achievers' assembly which took place last Friday 10 February. Nearly all students returned for the day and once again the Commonwealth Bank sponsored the highest ATAR.
  The assembly was viewed in ten OS countries.
